Wensman, Morton, Eaton. No: None. Motion carried.


JAMES BENGE/CLEARWATER ENTERPRISES – Current natural gas prices are significantly  
higher than the contract price which expires August 31, 2022. The NYMEX price today is \$9.363 per  
mmbtu. For the month of September 2022, the cost will be \$8.60 per mmbtu. A six-month contract,  
beginning October 2022, \$9.90. One-year \$9.50. Two-year \$9.20. Three-year \$8.58. Four-year  
\$8.14. Motion by Morton and second by Burch to wait until September 13-20 to see if the price drops.
