NATURAL GAS PURCHASE PRICE FOR OCTOBER – Cost per MMBTU of natural gas is estimated to be \$2.63 for the month of October.

ADVANCED MICROBIAL SALES – Tim Goodpasture gave the board a report on the results of the treatment that has been done at the wastewater treatment plant since April 2024. The percentage of sludge in the lagoon started at 61.07%. As of April 2025, the sludge has decreased to 42.4%. There has also been a reduction of nearly 50% in Total Suspended Solids, 50% reduction in Phosphorus and a doubling in the Nitrite/Nitrate, indicating that the ammonia levels have been reduced. The treatment and monitoring of the lagoon will continue through mid 2026.
