

RESOLUTION 2025-06

A RESOLUTION OF THE SPERRY UTILITY SERVICES AUTHORITY  
AMENDING RATES AND CHARGES FOR WATER SERVICE, REPEALING ALL  
RESOLUTIONS IN CONFLICT HERewith, AND CONTAINING OTHER PROVISIONS  
RELATED THERETO

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE SPERRY UTILITY  
SERVICES AUTHORITY THAT:

SECTION 1. MONTHLY CHARGES FOR WATER SERVICE.

- (a) The charges for water service inside the Town limits of Sperry shall be as follows:
1. First one thousand (1,000) gallons per month; twenty-four dollars and twenty-five cents (\$24.25) minimum charge; said minimum charge to apply to all premises with respect to which a security deposit has been made and a water meter installed, without reference to whether the subscriber takes water through such meter.
  2. Two thousand (2,000) gallons to twenty thousand (20,000) gallons per month; nine dollars and ninety-five cents (\$9.95) per one thousand (1,000) gallons.
  3. Over twenty thousand (20,000) gallons per month; nine dollars and five cents (\$9.05) per one thousand (1,000) gallons.
- (b) The charge for water service outside the Town limits of Sperry shall be as follows:
1. First one thousand (1,000) gallons per month; twenty-six dollars and fifty cents (\$26.50) minimum charge, said minimum charge to apply to all premises with respect to which a security deposit has been made and a water meter installed, without reference to whether the subscriber takes water through such meter.
  2. Two thousand (2,000) gallons to twenty thousand (20,000) gallons per month; ten dollars and eighty cents (\$10.80) per one thousand (1,000) gallons.
  3. Over twenty thousand (20,000) gallons per month; nine dollars and ninety-five cents (\$9.95) per one thousand (1,000) gallons.

(c) Multiple units with single meter fees:

Where two (2) or more family, residential, commercial business or industrial units are supplied with water through a single meter, the minimum charge of twenty-four dollars and twenty-five cents (\$24.25) per month, per unit, shall be made for the first one thousand (1,000) gallons, multiplied by the number of units so connected, or a fraction thereof, without regard as to whether or not any such unit or units be vacant, used or occupied. The minimum charge for outside the Town limits under these conditions shall be twenty-six dollars and fifty cents (\$26.50) per month, per unit.

SECTION 2. ALL OTHER RATES AND CHARGES FOR WATER SERVICE SHALL REMAIN  
UNCHANGED, unless expressly amended by this resolution.

SECTION 3. The charges for water referenced herein shall become effective on the July 2025 billing cycle.  
(Billings on and after August 1, 2025)

SECTION 4. All Resolutions or parts thereof, in conflict herewith, are hereby expressly repealed.
